# Coordination of Nordic Building Regulations

27 October, 2025 | Hotel Sheraton, Stockholm

## Towards a Common Nordic Construction Market

**The Nordic Council of Ministers, the Association of European Border Regions, and the Svinesund Committee are organising a workshop on coordination of Nordic building regulations across borders as a way of unlocking new sustainable construction markets.**

**Invited participants:** Members of the Nordic Steering Group for Harmonisation of Building Regulations, representatives of relevant trade associations and relevant political representatives.

### Background

In 2018, the Nordic construction and housing ministers agreed to a common Nordic building and construction market. They agreed to make the Nordic Region the world's most integrated construction market that "ensures better and cheaper buildings ... for the benefit of Nordic citizens, the real estate sector and the construction industry." Today, seven years later, we still have Europe's highest construction costs, and it is still just as difficult for building and construction companies to carry out projects in neighbouring countries.

However, the conditions for a common Nordic construction market are better than they have been in a long time. Several of the Nordic countries are in the process of simplifying building regulations by reducing detailed control and delegating more responsibility to construction companies. The digitalisation of the construction process requires clear and unambiguous terminology, which is a necessary prerequisite for harmonising regulations. And the EU is pushing for a green transition of the construction sector that requires similar regulations in all member states.

With this seminar, the Nordic Freedom of Movement Council, the Svinesund Committee and the Association of European Border Regions want to draw attention to the opportunities that better coordination of Nordic building regulations across borders brings. Which differences in building regulations do companies in the construction and civil engineering sector see as the most costly to manage? If these can be eliminated, what are the opportunities for more efficient construction? What advantages do housing companies see in a common Nordic construction market? And what development potential can it unleash in the Nordic border regions?
